**Early Order Discounts:** 2% on MC corn orders placed by September 30, 2017; 1%, if ordered by December 31, 2017. **Early Payment Discounts:** Payment postmarked by September 25<sup>th</sup>, 2017, deduct 12%; October 25<sup>th</sup>, 2017, 11%; November 25<sup>th</sup>, 2017, 10%; December 23<sup>rd</sup>, 2017, 9%; January 25<sup>th</sup>, 2018, 8%; February 25<sup>th</sup>, 2018, 7%; March 25<sup>th</sup>, 2018, 6%. Invoices after March 25<sup>th</sup>, 2018, payments postmarked within 5 business days of delivery, deduct 5%.

**Syngenta Technology Agreements/Discount:** Customers presenting their Syngenta number or signing an agreement when placing their order receive an additional \$10 per unit discount. Purchase of traited hybrids requires signing an agreement.

Price includes the following treatments: Micromaster, Standard MC treatment, CruiserMaxx Corn 250, Avicta Complete Corn 250. Micromaster on non-GMO hybrids and Cruiser 1250 must be specified by January 1,2018. Cruiser 1250 available in skid lots only. See page 08 of 2017-18 MC Hybrid Resource Guide for trait and treatment descriptions. **Returns:** Only seed labeled for 2018 in clean, undamaged, original MC bags (no tape, etc) will be accepted for return through June 15<sup>th</sup>, 2018.
